

Scholarship Eligibility

- ◆ Eligibility: Alaska residents who have completed their secondary education and wish to have a career in one of the many diverse facets of the public works field that plan, build, maintain and improve our communities.

Scholarship Conditions

- ◆ The scholarship winner must agree to complete the objective for which the scholarship was awarded within 18 calendar months of award. If for some reason the scholarship monies are not used, they will be returned to the Chapter.
- ◆ The scholarship winner will also be required either to attend an APWA meeting to report on the progress toward his/her goal, or to submit a written report if unable to attend.

Scholarship Award

- ◆ Scholarships will be announced at the June APWA meeting. APWA Alaska Chapter meetings are usually held the Third Thursday of the month.

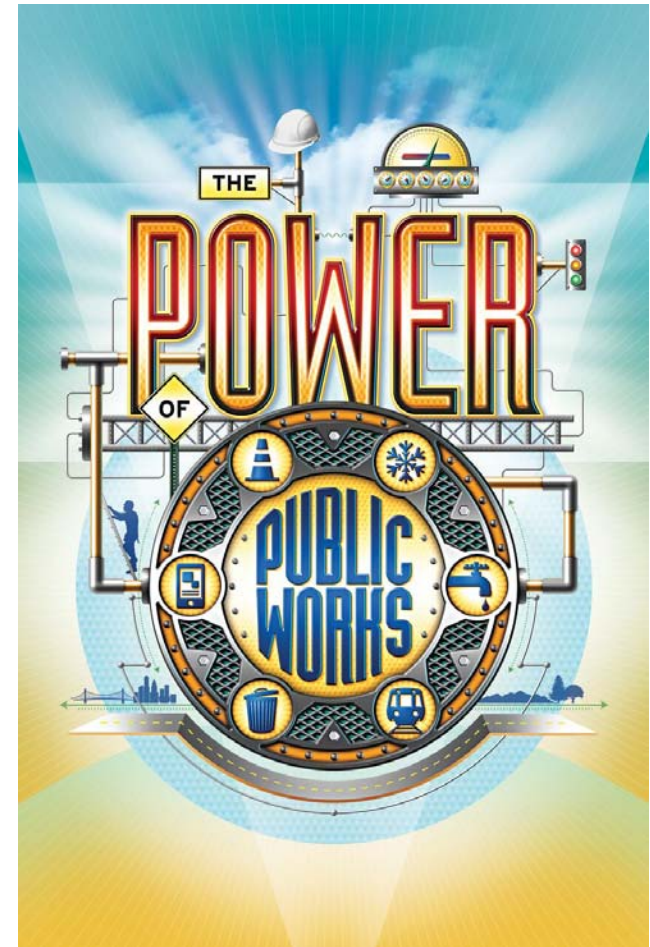
The American Public Works Association (APWA) is an international educational and professional association of public agencies, private sector companies, and individuals dedicated to providing high quality public works goods and services.
